

2.0 Requirements

- The touchscreen is for indoor use only. Do not install it where there is moisture or direct sunlight or a direct source of heat.
- Using any non-C-Bus software with C-Bus hardware without the written consent of Clipsal may void any hardware warranties.
- Changes or modifications not expressly approved by Clipsal could void the user's authority to operate the equipment (under FCC rules).
- To comply with EMC regulations the included ferrite filter must be fitted to the C-Bus cable connected to the touchscreen.

3.0 General Description

The C-Bus Black & White MK II Desktop Touchscreen displays pages of graphical information to control an entire C-Bus system from one location. Using appropriate software, the unit can be configured to look and operate in a manner convenient to the user. Refer to Programming Requirements for further details.

3.1 Packing List

The touchscreen product includes:

- desktop unit, consisting of touchscreen, base, pedestal and silver coloured accent strip
- 5 metre extendable C-Bus cable with RJ45 connectors
- USB type B cable, for programming
- stylus
- 1 ferrite filter
- *C-Bus Black & White MK II Desktop Touchscreen Installation Instructions*, 1038828 (this booklet)
- *C-Bus Black & White MK II Desktop Touchscreen User's Guide*, 1038827

The items shipped are subject to change without notice.

3.2 Features

The touchscreen's features include:

- a touch-sensitive 4.7 inch active black & white LCD screen
- C-Bus network port, using an RJ45 connector
- inbuilt infrared (IR) receiver
- inbuilt light level sensor
- real time clock for automatic scheduling of events
- logic engine (specified models only), providing the ability to perform control functions based on programmed algorithms
- 1 USB programming port

- 1 RS232 serial port (logic engine models only) The serial port is used to interface to third party products using the logic engine. It is not used for programming the unit.

4.0 Installation Procedure

4.1 Location

It is important to select the right position for the touchscreen.

- The unit has a typical viewing angle of 45° to the left and right. The screen tilts from 10° to 45° (illustrated in Figure). Take this into account when choosing the mounting height.
- Provide easy access to the unit for switching lights and selecting scenes.
- The touchscreen is designed for indoor use only. Keep the touchscreen clear of places subject to water, humidity, direct sunlight and heavy dust.
- Avoid obstruction to the reception of infrared signals from a remote control.
- Do not mount opposite windows or other sources of bright light, as the reflections make viewing difficult.




Figure 1. Consider viewing angles when mounting the unit

4.2 Multiple Units




Figure 2 . Take care not to overlap IR transmission/reception zones

Multiple touchscreens can be installed on a C-Bus network. These units may be programmed to operate cooperatively or independently of each other. Take care not to mount units where a single IR remote control transmission can be received by multiple units (illustrated in Figure 2). Otherwise, multiple units may trigger a scene, with unpredictable results.

4.3 Permanent Mounting Option

As an option, the touchscreen can be permanently mounted on a tabletop, desk or shelf using the two mounting holes provided in the baseplate. You do not need to disassemble the touchscreen to mount the unit permanently.

Note: Connect the logic wiring before permanently attaching the touchscreen to any solid surface. After mounting the unit, you will have difficulty changing the wiring connections at the bottom of the baseplate.

To attach the baseplate to a solid surface, follow these steps:




Figure 3. Mounting screw hole locations

1. Using a small flat-blade screwdriver, pry the cover from the baseplate at the two slots at the back of the base. See Figure 3.

2. Separate the base cover from the baseplate and rotate the cover to reveal the mounting screw holes.
3. You should use mounting hardware appropriate for the surface where the unit is attached.

5.0 Wiring Connections

5.1 Logic Connections




Figure 4. Base bottom connectors

The C-Bus and RS232 logic connectors are located on the bottom of the touchscreen base (Figure 4). The USB programming connector is located on the right side of the touchscreen.

Purpose	Type	Location
C-Bus	RJ45	base bottom
RS232 Logic	3.5 mm	base bottom
USB	USB type B	right side of touchscreen

Note: The RS232 connector is present on all units. It does not have any effect on touchscreens without the logic engine feature.

5.2 C-Bus Network Connection

An expandable network cable with RJ45 connectors is supplied with the touchscreen. Connect one end of the C-Bus network cable to the base of the unit. Connect the other end of the cable to the network.




Figure 5. C-Bus cable conductor assignments

If the installation requires a longer cable, use Cat-5 unshielded twisted pair (UTP) C-Bus cable, and an appropriately wired 8-pin RJ45 plug. Refer to Figure 5 for wiring details. The Clipsal catalogue number for the C-Bus Cat-5 UTP cable is 5005C305B.




Figure 6. Remote On/Remote Off wiring diagram

The Remote On/Remote override functions are optional. However, if more than one C-Bus cable is connected to the unit, the Remote Override connections should be maintained across the cables to ensure correct operation of these services as shown in Figure 6.

5.3 RS232 Connection (logic engine models only)

The RS232 port allows you to connect external devices to the touchscreen. The RS232 serial port connection consists of a 3.5 mm stereo socket with pinouts for Rx/D, Tx/D and GND. Pinouts are provided in the following table.

	Pin	Name	Description

Table 2. RS232 connector jack pinouts

Note: If using the RS232 port, cable length should be limited to 15 metres for communication at up to 19,200 bps, or 7.5 metres at 38,400 bps. An RS232 cable is available (Clipsal cat. number 500OCT2RS232).

5.4 Installing the Ferrite Filter

The ferrite filter clamps around the C-Bus network cable. The filter reduces electrical interference for compliance with EMC regulations. Install the filter after installing the C-Bus cable connections.




Figure 7. Close the ferrite filter around the C-Bus cable

6.0 Removing the Fascia




Figure 8. Removing the fascia

The following steps are illustrated in Figure 8. To remove the fascia:

- 1) Pull the accent strip from the lower part of the fascia using your fingers only. No tools are needed.

- 2) Remove the three machine screws from the bottom front of the fascia with a #2 cross-tip screwdriver.
- 3) Release the fascia tabs from the touchscreen by carefully pulling the fascia away from the touchscreen body.

7.0 C-Bus Power Requirements

The touchscreen draws 65mA from the C-Bus network. The unit does not supply power to the C-Bus network.

Adequate C-Bus Power Supply Units must be installed to support connected devices. The Network window of a C-Bus Toolkit project provides a summary of a C-Bus network according to the units added to the Database. This can be helpful in determining the power supply requirements of a particular network.

8.0 Power Surges

Each unit incorporates transient protection circuitry. Additional external power surge protection devices should be used to enhance system immunity to power surges. It is strongly recommended that overvoltage equipment such as the Clipsal 970 be installed at the switchboard.

9.0 Megger Test Note

Do not megger test the C-Bus network cable.

10.0 C-Bus Programming Requirements

C-Touch Project

The touchscreen must be configured using a software project that has been customised for a particular C-Bus installation. A project is produced using the Programming Interface for C-Bus Embedded Devices (PICED) software. The PICED software is available from the Downloads section of the CIS web site (<http://www.clipsal.com/cis>). Documentation and help files are included with the software.

Once you have produced a project using the PICED software, connect the USB programming cable from the touch screen to your PC. Use the 'Transfer Project to unit' option to upload the project to the touch screen. This option is located in the PICED software Transfer menu.

Unit Address

The C-Bus Black & White Desktop Touchscreen must be programmed with a unique unit address on the C-Bus network. C-Bus Toolkit is also used to change the state of the C-Bus system clock and burden, if required.

C-Bus System Clock

The C-Bus Black & White MK II Desktop Touchscreen incorporates a software selectable C-Bus system clock. The system clock is used to synchronise data communication over a C-Bus network. At least one active C-Bus system clock is required on each C-Bus network for successful communication. It is recommended that three units on a particular C-Bus network have clock circuitry enabled, to provide redundancy.

The touchscreen's C-Bus system clock is enabled as default. Its state can be changed from the unit's 'Global' tab in the C-Bus Toolkit software.

Obtaining C-Bus Toolkit Software

Use the C-Bus Toolkit software, available from the downloads section of the Clipsal Integrated Systems (CIS) web site (<http://www.clipsal.com.cis>).

Both the touchscreen and C-Bus Toolkit project files should be backed up and kept in an archive at your premises. It is also recommended to give a copy to the customer.

11.0 Unit Reset



The reset button erases **all** firmware and project data in the touchscreen. The unit will cease to operate until firmware and project data are reloaded.

The touchscreen has a button that can be used to recover the unit if the firmware becomes corrupt. The Unit Reset button is located behind the fascia, immediately above the USB connector. The button is pressed when the unit is powered, using a pin or paper clip to break the sticker through the white dot.

Do not use the reset button if the unit is operating normally. Contact Tech Support before pressing the Unit Reset button.




Pressing this button erases ALL firmware and project data in the unit and reset it. Once pressed, the unit ceases operation and displays a blank (black) screen. The blue power LED remains on. Firmware can be reloaded using the 'Recover C-Touch 2' option from the Transfer menu in PICED.

Term	Definition
load	An electrical device (such as a light) connected to a C-Bus output unit (such as a dimmer).
scene	A series of actions across multiple outputs, triggered by a single button. For example, on arrival home you could use a scene to switch on lights in the hallway, kitchen and lounge, and switch on a heater.
schedule	A sequence of events to occur at particular instances in the future.
backlight	The light behind the LCD screen providing visibility in varying lighting conditions.
